The repurchase program in East Capital Explorer completed on 10 October

East Capital Explorer AB hereby reports that the repurchase program was completed on 10 October 2012.

The repurchase program allowed the Company to buy back own shares from 8 August 2012 up and until 10 October 2012. During this period, East Capital Explorer repurchased a total of 685,111 shares, corresponding to 2.0% of the outstanding shares, at an average price of SEK 49.95 per share. Before 8 August 2012 the Company did not hold any own shares. The total number of shares in East Capital Explorer, including shares owned by the Company, amount to 33,709,706.

Mia Jurke, CEO East Capital Explorer, says: "There are currently many interesting investment opportunities given the attractive valuations in our markets, but we continue to as well evaluate other options to increase the shareholder value on the basis of the high share discount on NAV".
